Habitat & Trail Restoration: In 2017, WRV successfully increased and maintained a passionate, highly skilled volunteer community that cares for public and ecologically important lands. WRV was able to complete 128 restoration projects because this group of land stewards contributed over \$971,152 worth of labor and expertise. WRV volunteers:

- Restored over 5.5 miles of stream channel or shoreline
- Planted over 28,000 native plants and trees
- Restored over 4.95 acres of wetlands
- Constructed 16,000 feet of trails
- Seeded over 18 acres of land with native seeds

Volunteer Community Building: Currently, there are 412 WRV volunteers in the Ten Project Club (who have completed at least 10 projects). There are 203 in the 20 project club, 56 in the 50 project club, 19 in the 100 project club (!), and 38% of volunteers attended more than one project during the year! This program involves the recruitment and maintenance of a corps of thousands of on-call volunteers dedicated to the ecological stewardship and restoration of our natural heritage. In a sense, this is WRV's most crucial function.

Volunteer Leadership Development: In 2017, WRV held 23 courses and trained 194 volunteers in technical, leadership and safety skills. Since 2003, WRV has trained more than 3,000 volunteer leaders in skills including restoration design, crew leadership, trail maintenance and construction. In 2017, WRV held 34 events for diverse youth, including our High School Crew Leader Course, which graduates youth to lead crews of youth and adults in the field. During these events and courses, WRV provided diverse youth with almost 3,000 hours of service learning environmental education.
