Habitat & Trail Restoration: In 2016, WRV successfully increased and maintained a passionate, highly skilled volunteer community that cares for public and ecologically important lands. WRV was able to complete 117 restoration projects because this group of land stewards contributed over \$1,017,929 worth of labor and expertise in 2016. WRV volunteers:

- Restored over 5.9 miles of stream channel or shoreline
- Planted over 32,325 native plants and trees
- Restored over 4.95 acres of wetlands
- Repaired trails and stabilized streambanks at 14 post-flood events
- Closed and re-vegetated over 9.22 miles of habitat-fragmenting unused roads

Volunteer Community Building: Currently, there are 385 WRV volunteers in the Ten Project Club (who have completed at least 10 projects). There are 185 in the 20 project club, 51 in the 50 project club, 16 in the 100 project club (!), and 38% of volunteers attended more than one project during the year! This program involves the recruitment and maintenance of a corps of thousands of on-call volunteers dedicated to the ecological stewardship and restoration of our natural heritage. In a sense, this is WRV's most crucial function.

Volunteer Leadership Development: In 2016, WRV held 21 courses and trained 156 volunteers in technical, leadership and safety skills. Since 2003, WRV has trained more than 2,850 volunteers. We also held 20 events for diverse youth, including our High School Crew Leader Course, which graduates youth to lead crews of youth and adults in the field. WRV provided over 1,400 hours of service learning environmental education. WRV's success in fostering leadership and a sense of volunteerism will contribute to a strong, diverse stewardship movement in the future, and equip this generation with tools to address increasingly critical natural resource challenges.
