Natural Habitats - WRV's core restoration program responds to diverse needs across our region, whether it's restoring sensitive alpine areas, rehabilitating parklands, or replanting wetlands. Specialties include improving habitat for sage grouse by building rock structures and improving habitat for beaver by planting willows and building beaver mimicking structures. We also close and revegetate unused roads, and create pollinator habitat with local farms through a restorative agriculture initiative. In 2020, WRV volunteers repaired 3,624 ft of wildlife-protecting fence and restored 5,350 ft of unused roads. They planted over 7,332 native plants, shrubs, and trees, which rebuild soil, sequester carbon, and create food, forage, structure, and shade for native species.

Sustainable Trails - WRV's philosophy with trail work is to re-route unsustainable trails away from sensitive areas to avoid damage. We establish precedent to stop vehicle trespass while allowing foot traffic where appropriate. We cease erosion caused by trampling by establishing a single route to the views visitors seek. WRV closes and reclaims old trails, constructs new segments and connections, and prevents erosion by maintaining trails. We rebuild trails that have been destroyed by fire, flood, or bark beetles, and create more sustainable routes. Over WRV's 21 years, we have completed over 122 miles of trail work, and in 2020 alone we completed 56 miles, including clearing downed trees with crosscut saws from 50 miles.

Youth & Families -WRV provides diverse youth with broad environmental education experiences that build knowledge & awareness; promotes critical thinking; and encourages service and community leadership. WRV's Youth Leadership Development (WYLD) program enlists youth to deliver programs for their peers and plan youth-led restoration projects to showcase their skills and passion to their families and the community. WRV and partners host Youth Exploring Stewardship (YES), a two-day annual conference for youth from across the region. In 2020, WRV engaged over 454 youth and families who thinned six acres of forest, planted 658 native trees, plants, and shrubs, treated 1.86 acres of invasive species, removed 2,388 ft of habitat-fragmenting fence, and more.

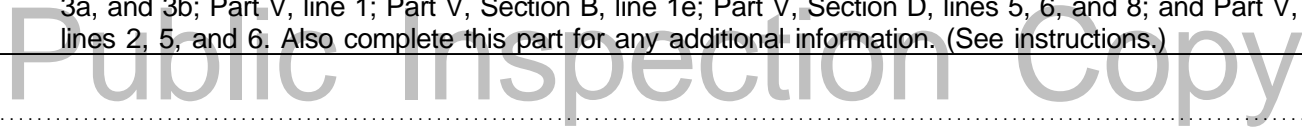

The Organization depends on amazing volunteers who donate their labor and expertise. In 2020, 817 volunteers donated 21,510 hours of service during the year, many of whom attended multiple projects. Management estimates that these services had a value of approximately \$585,782.

Training & Community Building - In 2020, WRV developed and maintained a passionate, highly skilled volunteer community that cares for public, protected, and ecologically important lands. Despite delays, budget cuts and group size limits imposed by the COVID19 pandemic, WRV was able to complete 151 restoration projects & trainings. Over \$582,000 worth of labor and expertise was contributed by volunteers over 2,280 attendances. These volunteers benefitted over 16,000 acres of wildlife habitat in 2020 alone. This is only possible because of the dedication of donors, foundations, volunteers, and volunteer leaders. In 2020, WRV held nine courses and trained 113 volunteers in technical, leadership, and safety skills. Vital Rivers - Waterways are the lifeblood of our communities, and over 80% of Colorado wildlife depends on them! Over WRV's 21 years, volunteers have restored over 63 miles of stream channel & shoreline and over 89 acres of wetland. Much of this work in the past seven years has focused on

stabilizing streambanks after floods damaged them, and on removing noxious weeds that flooding dispersed. In 2020, WRV volunteers restored over a mile of stream channel and 11 acres of wetland.

Expenses 82,574; Revenue 27,497

Native Seeds - Restoration projects require a diverse supply of native trees, shrubs, grasses and wildflowers that are genetically adapted to thrive in this area. People of all ages join us to collect, clean, and grow-out native seeds. Volunteers also help tend plants in a greenhouse and nursery. Over WRV's 21-year history, volunteers have contributed over 39,471 person-hours of native seed collection and spread untold millions of seeds! In 2020, volunteers spent over 6,630 hours collecting native seeds to be grown-out or used on future projects.

Expenses 78,751; Revenue 48,952

Invasive Weeds - Invasive weeds threaten to overtake natural lands, crowding out native plants and animals and weakening natural systems. WRV prioritizes efforts on weeds which are mandated for eradication by the State of Colorado. Over WRV's history, our volunteers have weeded 6,716 acres! In addition, as a result of these efforts, thousands of residents now can identify and safely remove these invasive species, preventing the damage they do to native habitat. In 2020, volunteers weeded over 283 acres.

Healthy Forests - Colorado's forests have been affected by unnatural fire suppression for decades, leading to catastrophic fires in a warming system. But, we can protect roads, homes and municipal water filtration plants from

the flooding and mudslides that follow. Not to mention help rare native species return and restore natural system function. Trained volunteers use chainsaws to conduct forest thinning projects in communities at the edge of the forest. After the catastrophic fires in our region in 2020, WRV anticipates a great deal of post-fire watershed stabilization in the years to come. In 2020 alone, WRV sawyers restored 20 acres to forest health.
